CASA for Douglas County is pleased to announce the 9th Annual 5K Superhero Run on August 24, 2019 at Stinson Park in Aksarben Village. For the first time ever, we are expanding the Superhero Run into an all-day, family fun festival. We hope this new approach will engage more people in the important mission of our organization.

A Court Appointed Special Advocate is a community volunteer appointed by a Juvenile Court judge to represent the best interests of one child or sibling group at a time. The volunteer remains for the life of the child's case, until a permanent "forever home" is found for each child. A CASA Volunteer is often the most consistent presence in a child's life.

There are over 1,500 children in the child welfare system in Douglas County. At the moment, only 30% of these children are appointed a CASA Volunteer. With your support, we will achieve our vision of providing a CASA Volunteer to every child in foster care who needs one by 2020.

The Superhero Festival & 5K Superhero Run is an effort to raise awareness about children in foster care and how CASA lifts up their lives and voices through the advocacy of volunteers. CASA relies on the generosity of local businesses, organizations, and individuals to ensure the success of this event and our work. Your support will help us train, empower, and inspire more volunteers to improve the lives of abused and neglected children.
